Faculty of Economic Sciences at the University of Warsaw is looking for a student at a second- or third-year BA studies, a Masters or PhD level to work in National Science Centre OPUS 18 grant "From knowledge networks to interregional innovation systems in the context of decentralized power for regions" (No. 2019/35/B/HS5/04010, principal investigator, Dr. Adi Weidenfeld).

The Candidate has to provide a proof of being a registered student <u>in Poland</u> (evidence is required) and speaking, writing and reading Polish <u>at mother tongue level</u>.

Students can continue working 6 months after the expiry date of her/his student's status.

The stipend can be split into two positions in case the selected candidate could not be fully involved.

### **Description of tasks:**

For an OPUS research project funded by the National Science Centre Poland on regional knowledge networks of destination regions led by Dr Adi Weidenfeld and international reputable academics from top Universities including Prof Rodolfo Baggio (Bocconi University, Milan), and Prof Michal Zemla (Jagiellonian University). A successful candidate is needed for undertaking qualitative data collection and analysis, potentially also social network analysis as well as assisting in writing up coauthored publications and reports and presenting in national and international conferences. Ideally s/he should have experience in undertaking interviews in Polish and English and performing social-network analysis or willingness to learn and acquire this skill. Funding is available for up to 12 months.

The student will be asked to coordinate and undertake interviews with senior officers in local authorities and other organisations in Poland and possibly online interviews in other countries, collect and analyse secondary online data and questionnaire surveys, perform social network analysis as well as engage in various academic activities.
