

## Position: Research Assistant

Interested in how media and digital entertainment change the face of economics and compete for your limited attention?

The Faculty of Economic Sciences of the University of Warsaw announces applications for the position of a Research Assistant in the research project **“Economic analysis of competition for attention - the case of digital entertainment sectors”** led by dr Wojciech Hardy and funded through an NCN OPUS grant.

The project covers the aspects of cross-sector competition for consumers’ attention, firm strategies for building and retaining attention and the value of attention and privacy in the context of digital entertainment (think “Netflix vs Fortnite vs TikTok”). The project is in its final stage and now focuses on finalizing research articles and studies. We’re looking for a PhD student who would take on the co-author role and help us achieve our goals.

## What we offer

- 1800 PLN monthly scholarship;

- start of work: as soon as possible (preferably October 2024);
- hybrid (flexible) work arrangements (possible work-from-home with some on-site work required).

## Requirements

- MSc (or near defense) in Economics, Mathematics, Sociology or Psychology.
- Good scientific writing skills (e.g. based on previous works).
- Good command of English.

## Optional (but very welcome)

- Good publishing track record.
- Experience in topics related to digitisation and digital economy will be an asset.
- Good knowledge of media trends and interest in the topics of the project.
- Good programming, modelling, econometric skills.

## Scope of work

Tasks will vary depending on the stage of a particular research study, but will focus on finalizing existing research studies (e.g. by developing final codes for existing datasets and co-writing the articles). Creative inputs to the eventual shape of the articles will be welcome.

Required documents:

- 1) CV
- 2) Short motivation letter (incl. research interests, explaining reasons for application and why the candidate is a good fit for the position).
- 3) GDPR consent form (attached).
- 4) A sample authored publication (can be a working paper).
- 5) Signed Information on personal data processing.

In case of a close tie in applications, selected applicants will be invited to an interview (which can be online).
