# Research Assistant Position

The University of Warsaw, Faculty of Economic Sciences is seeking candidates for a research assistant to dr. hab. Marek Giergiczny (<u>https://scholar.google.com/citations?user=zratqEMAAAAJ&hl=pl&oi=ao</u>) to work on the project in NCN project OPUS22 "Development of a methodology for estimating cultural ecosystem services".

Short description of the project and its main goals

Ecosystems generate a range of goods and services important for human well-being, collectively called ecosystem services. Yet, it has turned out difficult to move from general statements about the very large benefits nature provides to people to credible, quantitative estimates of ecosystem service values. Spatially explicit values of services across landscapes that might inform land-use decisions are still very rare, the main goal of this project is to fill in this gap. This will be achieved by:

- developing a new approach to collect nature-based recreational data which will enable to understand and quantify how people make nature based recreational choices,
- developing a revealed preference modelling framework to model sites selection for recreation,
- developing a combined stated and revealed preference modelling framework which will enable to link recreational benefits with characteristics of different ecosystems.

The offer: scholarship of 4,000 PLN per month (flexible working hours) for 36 months (possibility to prolong the term), subject to an evaluation procedure after 6 months of employment.

This scholarship can be combined with the base scholarship for PhD students at the University of Warsaw (Social Sciences PhD school, Quantitative Psychology and Economics PhD program) and other funding (conditional on involvement in advisor's research projects).

Main strengths of successful candidates (at least one should apply):

- Interest in interdisciplinary scientific research, or/and
- Good command of English, academic writing in particular, or/and
- Computer programing or data science skills

Successful candidates might also have (preferable, but not a requirement):

- Experience in academic research, writing/editing texts in English, econometric modelling, knowledge of GIS tools
- Knowledge of R environment or other statistical software
- Ability to work independently and self-motivate
- Interest in interdisciplinary research combining economics and environmental sciences
- Recommendations from academics or professionals
- Economics or other social sciences, environmental or mathematics-related background

Main tasks involve literature reviews, programing, data analysis, drafting and editing academic publications, and designing new research studies.

# Controller

# Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law<sup>1</sup> (given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment) for the purposes of this recruitment process<sup>2</sup>, whereas other data<sup>3</sup> shall be processed based on your consent which may take the following wording:

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data<sup>4</sup> which may take the following wording:

I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in .....(e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent<sup>5</sup> which may take the following wording:

*I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.* 

You may revoke all such consents at any time by, for example, sending an email at ..... (email address due for the recruitment process).

Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation.<sup>6</sup>

### Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

# Data recipients

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

# Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms.
