Position: Student/Ph.D. student – scholarship in NCN project OPUS 19 "Accuracy of travel cost method in non-market valuation of public goods", PI dr Ewa Zawojska (one position)

Requirements:

- Ph. D. student in Economics (preferred) or BA/MA student in Economics;
- excellent English language skills (in speaking and writing);
- excellent Polish language skills (in speaking and writing);
- experience in writing academic papers in English;
- experience in preparing and giving conference presentations in English;
- past participation in research projects will be an asset;
- knowledge of statistical software R at least at an intermediate level.

Description of tasks:

The aim of the project is to assess the accuracy of the travel cost method in valuing public goods and design novel approaches to improve the method's accuracy.

The student co-investigator will be involved in:

- 1. collecting and analyzing the background literature;
- 2. collecting and processing the empirical data, including the preparation of a survey study, cooperation with a public opinion research company on the survey implementation for data collection, and verification and quality control of the data received from the company;
- 3. preparation of the data for the empirical analysis, including tasks such as (but not limited to) generating weights, recoding data to required forms, and collecting geospatial information on survey respondents based on their postal code information;
- 4. analyzing the empirical data using statistical and econometric tools, and preparing a report from the analysis;
- 5. serving as general support to the PI.

Employment conditions:

Scholarship of 3000 PLN/month for up to 9 months, subject to an evaluation procedure after 6 months of employment.

The position is available as of April 1st, 2024.

(The scholarship is awarded in accordance with the rules of granting scholarships in the regulations of research projects financed by the National Science Center (NCN), introduced by the Resolution of the NCN Council No. 25/2019 of March 14, 2019)

Information on personal data processing

Controller

Data Protection Officer (DPO)

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law¹ (given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment) for the purposes of this recruitment process², whereas other data³ shall be processed based on your consent which may take the following wording:

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data⁴ which may take the following wording:

I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent⁵ which may take the following wording:

Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

Data recipients

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

Recipients of personal data may be other subjects obligated by the Controller to provide specific services involving data processing, like

Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms. Your personal data may be also processed by our provider of G-Suit for education by Google Company in their data processing centres.⁷ Your data shall be protected under the standards of the Privacy Shield, accepted by the European Commission.⁸ This shall guarantee an adequate level of data security.

Rights of the data subject

Under the GDPR data subjects have the following rights:

- to access data and to receive copies of the actual data;
- *to* correct (rectify) your personal data;
- to restrict processing of personal data;
- to erase personal data, subject to provisions of Art. 17 section 3 of the GDPR;
- to file a claim with the <u>President of the Personal Data Protection Office</u>, if you believe data processing violates law.
