Additional information

- Student admitted to studies may choose the payment option until October 12, 2026 personally. From October 15, 2026, the system will automatically choose the way of payment in one installment.
- The individual account number for payment of tuition fees will be in the USOSWeb Student's system. Please do not make payments to other account numbers. The payment should be made to the account number in accordance with the currency of the payment (even if the payment is made in a different currency).
- An enrolled student who resigns before the beginning of the 2026/2027 academic year (i.e., before 1/10/2026) is not paying any fees.
- According to § 6 s. 1 of the Ordinance No. 130 of the Rector of the University of Warsaw of 30 September 2019 on the rules for charging and the conditions and procedure for exemption from the fees for educational services at the University of Warsaw „In the case of being expelled from studies due to the failure to undertake studies where education is paid, the fee is imposed in the amount of 10% of the fee payable for the first year of studies which is to cover the cost necessary to launch and conduct studies and prepare and implement the University strategy” (a failure to undertake studies is stated in particular when a person admitted to a course of study has not confirmed in writing taking the oath or has not enrolled in classes included in the study plan during the first month from the date of the beginning of the semester).
- According to § 6 s. 2 of the aforementioned Ordinance No. 130 of the Rector, in case of resignation from studies, the fee paid shall be reimbursed proportionately, i.e., after deducting the fee for the period from the beginning of the academic year until the day when the decision on expulsion from the studies became final.
