# RESOLUTION NO. 37/2025 OF THE TEACHING COUNCIL OF THE FACULTY OF ECONOMIC SCIENCES AT THE UNIVERSITY OF WARSAW FOR FIELDS OF STUDY: DATA SCIENCE AND BUSINESS ANALYTICS, EKONOMIA, EUROPEAN ENVIRONMENTAL ECONOMICS AND POLICY, FINANSE, INWESTYCJE I RACHUNKOWOŚĆ, FINANSE I RACHUNKOWOŚĆ, FINANCE, INTERNATIONAL INVESTMENT AND ACCOUNTING, INFORMATYKA I EKONOMETRIA, INTERNATIONAL ECONOMICS, QUANTITATIVE FINANCE

#### on the rules of partial exemption of the first-year students of the second-cycle studies in the fields of study: Quantitative Finance and Data Science and Business Analytics from the fee for educational services in the academic year 2025/26

Pursuant to § 7 sec. 5 in conjunction with § 7 sec. 2 item 1 and 2 in conjunction with § 7 sec. 1 of Ordinance No. 130 of the Rector of the University of Warsaw of 30 September 2019 on the principles for collection, as well as terms and procedure for exemption from the fees for educational services at the University of Warsaw (uniform text: Monitor UW item 306 as amended), the Teaching Council for the fields of study: Data Science and Business Analytics, ekonomia, European Environmental Economics and Policy, finanse, inwestycje i rachunkowość, finanse i rachunkowość, Finance, International Investment and Accounting, informatyka i ekonometria, International Economics, Quantitative Finance resolves as follows:

§ 1

- 1. Students who have been admitted to the Faculty of Economic Sciences for a second-cycle study taught in English in the fields of Data Science and Business Analytics and Quantitative Finance may apply for a partial exemption from the fee for educational services in the second semester of the second-cycle study.
- 2. The basis for the exemption is the ranking list of accepted students separate for each field of study.
- 3. The ranking list is created after the end of recruitment for the academic year and includes students admitted in all recruitment rounds. The ranking is created collectively for full-time and part-time students in a given field of study.

§ 2

The ranking list for the Data Science and Business Analytics programmes is created according to the formula:

Su x Ś x W

where:

- (Su) is a factor:
  - for having the status of a 'research university' (the Ministry of Science and Higher Education's "Excellence Initiative – Research University" Competition) by the institution that issues the diploma in the year of recruitment for studies at the University of Warsaw for those who completed first-cycle studies in Poland. Having the status of a 'research university' – a factor of 10, lack of this status – a factor of 9.
  - for the university's position in the Shanghai Ranking in the year of recruitment for studies at the University of Warsaw. Position 1-500 – a factor of 10, further positions or absence of a university on the ranking list – a factor of 9 for those who completed first-cycle studies abroad.
- (Ś) is the grade point average for first-cycle studies. Grade point average expressed on a scale other than the one used at the University of Warsaw (2-5) will be assimilated to it.

- (W) is a factor that totals:
  - 1.8 if one of the following conditions is met:
    - the candidate's curriculum included AT LEAST 90 hours of microeconomics and 90 hours of macroeconomics, and 60 hours of econometrics, and 60 hours of finance;
    - the candidate's curriculum included AT LEAST 150 hours of mathematical analysis and at least 60 hours of physics, or 60 hours of chemistry, or 60 hours of computer science, or 60 hours of finance;
    - the candidate's curriculum included AT LEAST 150 hours of mathematical analysis and 60 hours of mathematical statistics;
    - the candidate's curriculum included AT LEAST 180 hours in total in programming subjects such as: Programming in R, Python, SAS, C++, C#, Java and others.
  - 1 in other cases, when none of the above criteria is met.

### § 3

The ranking list for Quantitative Finance programme is created according to the formula: Su x  $\pm$  x W

# where:

- (Su) is a factor:
  - for having the status of a 'research university' (the Ministry of Science and Higher Education's "Excellence Initiative – Research University" Competition) by the institution that issues the diploma in the year of recruitment for studies at the University of Warsaw for those who completed first-cycle studies in Poland. Having the status of a 'research university' – a factor of 10, lack of this status – a factor of 9.
  - for the university's position in the Shanghai Ranking in the year of recruitment for studies at the University of Warsaw. Position 1-500 – a factor of 10, further positions or absence of a university on the ranking list – a factor of 9 for those who completed first-cycle studies abroad.
- (Ś) is the grade point average for first-cycle studies. Grade point average expressed on a scale other than the one used at the University of Warsaw (2-5) will be assimilated to it.
- (W) is a factor that totals:
  - 1.8 if one of the following conditions is met:

    - the candidate's curriculum included AT LEAST 150 hours of mathematical analysis and 60 hours of mathematical statistics;
    - the candidate's curriculum included AT LEAST 180 hours in total in programming subjects such as: Programming in R, Python, SAS, C++, C#, Java and others.
  - 1 in other cases, when none of the above criteria is met.

- 1. In order to apply for an exemption from tuition fees, an appropriate application must be submitted to the HTU in accordance with the procedure provided in the Code of Administrative Procedure no later than 30 days prior to the commencement of the classes that are the subject of the application, unless the HTU sets a different deadline for submission of the application.
- 2. The decision to grant a tuition fee exemption is made in accordance with the following rules:
  - a. the first 10% from the top of each ranking list 50% exemption;
  - b. the second 10% from the top of each ranking list 40% exemption;
  - c. the third 10% from the top of each ranking list 30% exemption;
- 3. If such an exemption cannot be granted due to lack of applicants, the exemption may be granted in another field of study covered by the exemption program according to the ranking criterion.

# § 5

The resolution comes into force on the day of its adoption.
