**on the exemption of the students starting second-cycle studies in the**  
**International Economics field of study in the academic year 2024/25**  
**from the fee for educational services**

Pursuant to § 7 sec. 5 in conjunction with § 7 sec. 2 item 1 and 7 sec. 2 in conjunction with § 7 sec. 1 of Ordinance No. 130 of the Rector of the University of Warsaw dated September 30, 2019 on the collection and conditions of and procedures for waiving fees for educational services at the University of Warsaw (Monitor UW, item 306, as amended), in conjunction with § 34 sec. 2 and 3 of Resolution No. 441 of the Senate of the University of Warsaw on the adoption of the Rules and Regulations for Studies at the University of Warsaw (Monitor UW, 2019, item 186), the Teaching Council resolves as follows:

§ 1

1. Students who have been admitted to the second-cycle study in International Economics may apply for a full tuition fee waiver for the first year of study.
2. It is possible to extend the tuition fee discount to the second year of study provided that credits are obtained for all courses included in the curriculum of the first cycle on time.
3. Only students who are citizens of member states of the European Union, the Swiss Confederation or a member state of the European Free Trade Agreement (EFTA) – parties to the Agreement on the European Economic Area – may apply for a tuition discount.

§ 2

1. The basis for the discount in the first year of study is the ranking list of those admitted for study.
2. The ranking list is created after the end of recruitment for the academic year and includes students admitted in all recruitment rounds.
3. The ranking list is created based on the following formula:

$$P \cdot \sum_{i=1}^N LG_i \cdot O_i,$$

where:

$P$  – is the conversion factor for having the status of a 'research university' (Ministry of Science and Higher Education's "Excellence Initiative - Research University" Competition) in the year of recruitment for studies at the University of Warsaw for those who completed first-cycle studies in Poland or for the university's position in the Shanghai Ranking from 1 to 500 in the year of recruitment for studies at the University of Warsaw. The conversion rate is

1 when none of the above conditions are met and 1,2 when at least one of the above conditions is met.

$LG_i$  – the number of hours of a course from a list that includes the groups of courses listed below;

$O_i$  – grade obtained in a given course (equivalent to the grading scale specified in the Rules and Regulations of Studies at the University of Warsaw).

4. The list of courses that can be included in the formula includes:
  - a) economic courses: microeconomics, macroeconomics;
  - b) mathematical and instrumental courses: analysis, algebra, mathematical statistics, probability calculus, econometrics;
  - c) majors (related in profile to the International Economics field of study): international exchange theory, macroeconomics of an open economy. Within this group of courses, two additional mathematical or instrumental courses, not previously mentioned, may be indicated as equivalent.
5. Each course from the list in item 4 can be proposed separately in any educational form (lecture, exercises, tutorials). The equivalence of the proposed course to the above-mentioned is decided by the HTU.

### § 3

1. In order to apply for a tuition fee discount, an appropriate application must be submitted to the HTU in accordance with the procedure provided for in the Code of Administrative Procedure no later than 30 days prior to the commencement of the class session that is the subject of the application unless the HTU sets a different deadline for submission of the application.
2. The decision to grant a discount in the first year of study is made on the basis of the information provided by the candidate with a statement of compliance.
3. A total discount on tuition fees in the first year of study shall be granted to a maximum of 10 students, representing no more than 50% of all students entering the International Economics field of study in that year.

### § 4

The resolution comes into force on the day of its adoption.
