

Faculty of Economic Sciences at the University of Warsaw is looking for two students/ PhD students, to work in National Science Centre OPUS 18 grant "From knowledge networks to interregional innovation systems in the context of decentralized power for regions" (No. 2019/35/B/HS5/04010, principal investigator, Dr. Adi Weidenfeld).

The candidates have to provide a proof of being registered students in Poland (evidence is required) and speaking, writing and reading in Polish and English.

Requirements:

Speaking, writing and reading in Polish and English at mother tongue level or similar level

Basic (minimum):

1. Masters in management, economic geography, business studies, economics or related field.
2. Interest in the subject of regional studies and economic geography.
3. Experience in undertaking interviews in Polish
4. Very good command of English and Polish, preferably proved with language certificates and if not this will be checked in the interview.
5. Preferred experience in carrying out academic research.
6. Ability to work independently.
7. Motivation for an academic research career and passion for the topic.

We offer the selected candidate the possibility to:

1. learning world-class research.
2. scientific career development.

Description of tasks:

For an OPUS research project funded by the National Science Centre Poland on regional knowledge networks lead by Dr Adi Weidenfeld and international reputable academics from top Universities including Prof Nick Clifton (Cardiff Metropolitan University, the UK), and Dr Cornelius Pylak, Lublin University of Technology. A successful candidate is needed for undertaking qualitative data collection and analysis as well as assisting in writing up co-authored publications and reports and presenting in national and international conferences. Ideally s/he should have experience in social-network analysis or willingness to learn and acquire this skill. Funding is available for 7 months.

The student will be asked to coordinate and undertake face-to-face and online interviews with senior officers in local authorities and other organisations in Poland and the UK, collect and analyse secondary online data and questionnaire surveys, perform social network analysis as well as engage in various academic activities. This is an exciting opportunity for paving the road to an international academic career.

A complete application should include:

2. Curriculum vitae with any scientific achievements (e.g. membership in research clubs, participation in scientific conferences, internships and trainings, awards and distinctions obtained) and details on your relevant research skills
3. Contact details of at least one researcher who could present his own opinion about the candidate,
4. A copy of the certificate confirming the knowledge of English at least at B1 level (or its equivalent);
in the absence of a certificate, part of the interview may be conducted in English,

Information on personal data processing

Controller

Data Protection Officer (DPO)

The DPO, however, does not proceed other matters, like handling recruitment procedures, collecting recruitment documents, providing information on current recruitment process.

Purpose and legal grounds of data processing

Personal data of candidates for employment shall be processed for recruitment purposes only.

Your personal data shall be processed in the scope as indicated by employment law¹ (*given name (names) and family name, date of birth, contact information as provided, education, professional qualifications, previous employment*) for the purposes of this recruitment process², whereas other data³ shall be processed based on your consent which may take the following wording:

If your documents include data as mentioned in Art. 9 section 1 of the GDPR (special categories of personal data), processing shall be possible upon your consent to processing such data⁴ which may take the following wording:

I agree to the processing of special categories of personal data, as mentioned in Art. 9 section 1 of the GDPR, provided in (e.g. CV, cover letter, and other submitted documents) by the University of Warsaw for realising my recruitment process.

The University of Warsaw shall be also processing your personal data in future recruitment processes upon your consent⁵ which may take the following wording:

I consent to processing of my personal data for the purposes of any future recruitment processes at the University of Warsaw for the period of the next nine months.

You may revoke all such consents at any time by, for example, sending an email at aweidenfeld@wne.uw.edu.pl (email address due for the recruitment process).

*Be advised that the revocation of your consent does not affect legal compliance of processing which had been completed upon consent before its revocation.*⁶

Data retention period

Your personal data collected in this recruitment process shall be stored over the period of three months from the date the recruitment process is completed.

In case you agree to process your data in future recruitments, your data shall be used over the period of nine months.

Data recipients

Officers authorized by the Controller shall have access to your personal data, the processing of which is in the scope of their duties.

Recipients of personal data may be other subjects obligated by the Controller to provide specific services involving data processing, like

Data transfer outside the European Economic Area (EEA)

Your personal data shall be disclosed to subjects authorized by law. Signing-in is through Google Forms. Your personal data may be also processed by our provider of G-Suit for education by Google Company in their data processing centres.⁷ Your data shall be protected under the standards of the Privacy Shield, accepted by the European Commission.⁸ This shall guarantee an adequate level of data security.

Rights of the data subject
